## With our help, Ian was awarded his War Pension

Ian Ewers-Larose was a medic in the RAF, serving a tour in the Falklands and on Operation Granby in the first Gulf War.

He explains how his health deteriorated after Service.

“Six to nine months after serving in the Gulf War, I became unwell.

“I collapsed at home and was rushed to hospital with a suspected brain haemorrhage. After days in hospital, it was found that the coating of my spinal column was destroyed.

“I was then discharged back to the RAF. I had to try and get on with my job without being

able to walk properly. I also had problems with vision in my left eye.

“As I was constantly falling ill, I was advised to take redundancy rather than be medically discharged.

“When I left the RAF, I went on a resettlement course where **RBL advised I apply for a War Pension**, which I did and I now have regular support for life.

“I was given £1,500 compensation and a letter for free prescriptions and war pensioner status.”

In 2021, we were there to provide practical solutions for mobility, housing, household items and debt.

## Who are the people whose lives I can change through a gift in my Will?

Our support starts after one day of Service and continues through life, long after Service is over. Gifts in Wills are essential to help us honour this long-term commitment to our Armed Forces community through a wide range of services specifically designed to meet their needs. By leaving a gift in your Will, you can help our Armed Forces community for generations to come.

### How we helped John overcome PTSD after serving in Iraq.

John was part of a search team looking for improvised explosive devices (IEDs) in Iraq, when he was hit in the shoulder by a sniper.

After leaving service, life for John was chaotic – he went through a number of different jobs, bereavement, and was unable to settle. He then called RBL for help.

“I spoke to Michelle who was great, she came out to see me, took me shopping, helped me get my flat, and some much-needed mental health support.”

The depression and anxiety caused by the things John witnessed followed him to Civvy Street, and he came back to RBL for an assessment. The doctor who saw John diagnosed him with severe PTSD, and then he started to get the help he deserved. Now, John is a pro golfer – playing and



winning, for Great Britain in a series of military veterans' tournaments against the USA.

### How we helped Chantelle come back from tragedy

Chantelle and Ryan met when they were 16. They got married and had two daughters, Rosie and Daisy.

After completing a six-month tour of Afghanistan, Ryan began to struggle. He was diagnosed with post-traumatic stress disorder, and, in 2015, he tragically took his own life.

“It was a horrendous time,” says Chantelle. “I didn’t know what to deal with first or which way to turn.” When a friend suggested

RBL might be able to help, Chantelle contacted us and met Annette, an Advice and Information Officer.

“Annette provided advice on how to get the paperwork I needed and also directed me to a solicitor for help with the inquest – just that support with the little things really took a weight off my shoulders. Also, our first Christmas without Ryan was very difficult, but RBL supported us through it.”

**Gifts in Wills help us to provide the long-term support many ex-Service personnel and their families need.**

### How we help Ron and Loraine live with his dementia

Veteran Ron started to display erratic and obsessive behaviour that was completely out of character.

It was not until two years later that he was diagnosed with CADASIL syndrome, a rare form of dementia.

The past few years have been difficult for both Ron, due to his ill health and early retirement, and his wife, Loraine – emotionally and psychologically.

Fortunately, we were able to provide one of our Admiral Nurses, Helen, to support both Ron and Loraine.

**Admiral Nurses** give much-needed specialist care to veterans with dementia and they also provide moral support to those who look after them.

When Helen made her first visit, Loraine was experiencing carer stress and anxiety.

“Helen has allowed me to express myself and this sort of support has been essential in helping me cope with not only Ron’s changing personality, but my own,” said Loraine.

“I’m not alone. Helen has been there at the end of the phone and on visits to help us both and I look forward to her coming.”

### How RBL’s Battle Back Centre helped Mark

Donna is a former Royal Navy Able Seaman and was on deployment when she met her future husband, Mark. The couple went on to have three children.

Mark was serving in Afghanistan as a Gunner with the Royal Artillery’s 29 Commando Regiment, when his vehicle was blown up by a roadside bomb.

The blast caused devastating injuries and Mark needed to have his left leg amputated. He also broke his back.

“I was in the Navy in Scotland and I got a call to say that Mark had been injured and he only had a 20% chance of survival,” explains Donna.

“I had to wait a week to see him, which was the worst week of my life.”

Mark was one of the first wounded soldiers to benefit

from the RBL-funded, Battle Back Centre (Lilleshall). There he was given an individual recovery plan, which helped him and his family adapt to his new life with a prosthetic limb. Mark has been medically discharged from the Army and now helps elderly people in care homes.

Donna added, “Everyone has their own story. I think about our family, what we deal with on an everyday basis and what it’s like living with someone that got injured.

“And I think about all the people that sadly didn’t make it back and about the sacrifices that people currently serving in the Armed Forces make.”

# What do I need to do to write or amend my Will now?

Writing a Will can help to ensure that your family will be taken care of after you have gone. By putting your wishes in writing, you can also spare them a lot of extra worry at what can be a very stressful and emotional time. If you do not leave a Will, your estate will be divided up according to intestacy rules, which means it may not necessarily go to the people and causes that you would like it to.

If you are making a Will for the first time, you should make an appointment with a solicitor. It is a good idea to

make a list of all your assets before you go, including any savings, investments, and your possessions. Also think about the people and causes you would like to benefit from your estate. The Will Planner section at the back of this booklet will help. If you see your solicitor and decide leave a gift to RBL, please let us know so we can thank you.

If you have already made a Will and now wish to add a gift to RBL, you can use the simple **Codicil Form** that you will find at the back of this booklet.

## Write your Will free of charge

You can take the hassle out of writing a Will by using our free Will-writing service.

We offer three ways to do this:

1. Online
2. With a local solicitor
3. Over the phone



**1. Write your Will online for free** With our trusted partner, Farewill\* you can write your Will from the comfort of your own home. It is quick and simple to do and is **free** for those in England and Wales. Once written, your Will is thoroughly checked by an expert. To make your Will for free now, visit **farewill.com/rbl-willguide** and the discount code **RBL-WILLGUIDE** will be automatically applied at the checkout, so you don't pay any fees.

## 2. Write your Will for free with a local solicitor

If you would prefer to talk about your Will in person, we can put you in touch with a trusted solicitor in your area through the National Free Wills Network. You simply arrange an appointment to draw up your Will for free at a time that suits you. Complete our form online at **rbl.org.uk/giftinwill6** or call us on **0345 845 1945** to request a free Will-writing pack in the post.

## 3. Write your Will for free over the telephone

If you cannot make it to an appointment with a solicitor or do not have access to the internet you can call our partners, Farewill\*, on **020 8050 2686** to book a telephone Will-writing appointment. Let them know that you are using the service with RBL to get your Will written for free.

# How do I leave a gift in my Will?

## Your questions answered

Leaving a gift in your Will can ensure that our vital work to support the Armed Forces community can continue after your gone.

A gift to RBL, can also reduce the amount of inheritance tax paid by your loved ones enabling them to enjoy more of your gift to them.

Here, we answer some of the questions we are most often asked about making a Will and including a gift to RBL.

### If I leave RBL a gift in my Will, can I have a say in how it is used?

You can – but it is often more helpful to leave your gift to our general charitable purposes. We always want to be sure that the gifts we receive are used where they are most needed, and it can be hard to predict which areas we will need to focus on in the future.

You may choose to make an 'Expression of Wish'. This enables you to express a preference for how your gift will be used, whilst giving RBL flexibility should the service be fully funded or no longer exist.

### Do I have enough money to leave a gift in my Will?

Short answer – yes. Even as little as 1% of your estate would be a really big help to our Armed Forces community, whilst still ensuring your loved one's are provided for.

### How much does it cost to make a Will?

It generally costs between £100 and £300 for a simple Will, but we always recommend asking your solicitor for an estimate in advance. If your Will is straightforward, you may be eligible for RBL's **free Will-writing service**. You can read about this service on the previous page of this booklet.

### I have already made my Will – how can I change it?

You can change your Will by writing a new one, or amending it using a document called a **codicil**. A codicil does not replace your Will, so you should always keep both documents together. If you need to update your Will, you can do so using one of our free Will-writing services.

Today, the Centre supports any wounded, injured and sick Service personnel, including those with mental health problems, regardless of where they have served, to have the best possible recovery and helps them back to a fulfilling life, whether that is returning to duty or successfully transitioning to civilian life.

# Adding a gift to your Will

If you have already made a Will and would like to add a gift, here is a suggested example of a codicil, which is an appendix to a Will. This is a legal document which needs to be completed in the same way as your original Will, particularly with regard to signing and witnessing. When you have completed your codicil, please ensure that it is stored together with your original Will.

RBL would also recommend checking your codicil with a solicitor or legal adviser to ensure it meets your requirements.

## What wording can I use to include a gift in my Will to the Royal British Legion?

As a charity, RBL cannot give you legal advice about how best to write your Will. Below is some suggested wording that you may wish to use, to include a gift to RBL. You should always get this wording checked with your own solicitor or legal advisor before signing.

All gifts should be left to the Royal British Legion and should state our **Registered Charity Number: 219279**, together with the correct registered address: **Royal British Legion, Haig House, 199 Borough High Street, London SE1 1AA.**

### The suggested wording for a Pecuniary Gift (general charitable purposes) is:

I give the sum of [.....] pounds (£) free of inheritance tax to the **Royal British Legion (Reg Charity No: 219279) of Haig House, 199 Borough High Street, London SE1 1AA** absolutely for its general charitable purposes and the receipt of the Honorary Treasurer or the proper officer for the time being of the Royal British Legion shall be a complete discharge to my executors.

### The suggested wording for a Pecuniary Gift (with Expression of Wish):
