

## RBL's Centenary Jackpot Prize Draw

### Terms & Conditions

1. RBL's Centenary Jackpot Prize Draw is open between 29th April 2021 and 31st January 2022.
2. A qualifying entry to RBL's Centenary Jackpot Prize Draw is an entry made via one of the following methods;
  - RBL Poppy Raffle – Players of the Poppy Raffle will receive one entry for each Raffle they respond to between 29th April 2021 and 31st January 2022, regardless of the number of entries purchased for each draw. The Raffles in this period are our Spring Raffle 2021, Summer Raffle 2021 and Winter Raffle 2021. You can enter the respective Raffle if there is a Raffle live during a specific period, or alternatively the next Raffle, by visiting our website: [www.poppyraffle.org.uk](http://www.poppyraffle.org.uk)
  - RBL Extra Chances – Active Lottery players who receive a Raffle pack (Quarterly Draw) offering additional opportunities to purchase entries to a Raffle, will receive one additional entry into the Centenary Jackpot Prize Draw for each Raffle (Quarterly Draw) they purchase extras chances for between 29th April 2021 and 31st January 2022, regardless of the number of entries purchased for each draw. The Raffles (Quarterly Draws) in this period are our Spring Raffle 2021, Summer Raffle 2021 and Winter Raffle 2021. Lottery Players wishing to receive extra chances to purchase Raffle tickets should call supporter care on 0345 845 1945.
  - Poppy Lottery Players will receive an entry if their subscription is active during any non-Raffle draw during the period 29th April 2021 to the 31st January 2022. A total of one entry is available, regardless of the number of draws entered, or the number of plays. You can join the weekly Lottery here [www.weeklylottery.org.uk/PoppyLottery](http://www.weeklylottery.org.uk/PoppyLottery)
  - In addition, weekly Poppy Lottery Players who are active for each of the Raffle Draws detailed above will receive an entry for each Raffle they are entered into as part of their lottery subscription. For the avoidance of doubt, if a Lottery player plays for all of 2021 then they will be eligible for 4 Centenary Prize Draw entries.
  - RBL Poppy Raffle Subscription – Players of the quarterly subscription Raffle will receive one entry for each Raffle their Raffle subscription is active for during the period of 29th April 2021 and 31st January 2022. You can become a Raffle subscriber here <https://www.poppyrafflevip.org.uk/> For the avoidance of doubt, if a Poppy Raffle Subscription player takes part in all 3 2021 Raffles then they will be eligible for 3 Centenary Jackpot Prize Draw entries.
  - RBL Poppy Prize Draw – Players of the Poppy Prize Draw will receive one entry for each Poppy Prize Draw they respond to between 29th April and 31st January 2022. The Prize Draws in this period are our May Poppy Prize Draw, August Poppy Prize Draw and December Poppy Prize Draw. You do not need to make a donation in order to be entered into the Centenary Jackpot Prize Draw via the Poppy Prize Draw channel. *Online entry to Centenary Jackpot Prize Draw*
  - You can enter online at [rbl.org.uk/100draw](http://rbl.org.uk/100draw). This entry is free and in addition to any entries you make via our Raffle, Subscription Raffle, Lottery or Prize Draws. Only one entry per person into the draw will be valid via the online form. Duplicate entries will be removed from the draw.
3. The maximum number of entries to the Centenary Jackpot Prize Draw is 11 per person, made up of 3x entries to Quarterly Raffle Draws (Spring Raffle 2021, Summer Raffle 2021 and Winter Raffle 2021) through the purchase of Raffle tickets or through an active Lottery Subscription, 3x entries to Quarterly Raffle Draws via Extra Chances for Active Lottery Players (Spring Raffle 2021, Summer Raffle 2021 and Winter Raffle 2021), 1x Additional entry for Poppy Lottery Players if you enter any non-Raffle Draw during the qualifying period, 3x entries from the Poppy Prize Draws (May Poppy Prize Draw, August Poppy Prize Draw and December Poppy Prize Draw) and 1x free online entry.
4. One prize winner will be drawn from all qualifying entries received by 31st January 2022. The winner will be drawn on 11th February 2022. Winners will be notified and cheques sent by 28th February 2022 to the name and address as provided at the time of entry.
5. Entrants must provide accurate entry information, including name, personal address, email address and phone number and inform the Promoter of any changes to these details as soon as they arise.
6. A random number generator will be used to pick the winning entry.
7. The Centenary Jackpot Prize is £30,000 cash.

8. Any prize cheques not banked by the recipient within 6 months of the date of issue will be cancelled and the value retained by the charity as a donation.
9. Details of the Prize Winner will be sent to anyone supplying a self-addressed envelope with their entry after the close date.
10. The Centenary Jackpot Prize Draw is run in accordance with the guidelines of the Direct Marketing Association and Code of Advertising Practice.
11. Entrants must be aged over 18 to enter the draw. Any entrant found to be under 18 will be removed from the draw. If a winner is selected who is found to be under the age of 18, that prize will be forfeit, with the prize allocated to another entrant.
12. The Promoter (RBL) reserves the right to use the data provided by entrants to verify against publicly available data sources that they are over the age of 18.

Those residing outside Great Britain, in Northern Ireland, the Channel Islands, the Isle of Man and overseas, are not permitted to enter. Any entrant found not to be a resident of England, Wales and Scotland will be removed from the draw. If a winner is selected who is found not to be a resident of England, Wales and Scotland, that prize will be forfeit, with the prize allocated to another entrant.
